Under old business, Mr. Jose Galvan addresses the Board regarding 1524 Summer Street. He states contractors are asking for over \$60,000 for renovation of property and he only has about \$30,000 in his budget. He talked with Mr. Koch and he suggested he talk with the Board to request keeping the slab and taking it off the demolition list. The slab is 24x30 feet and there are three walls up. Kelly states Mr. Galvan is afraid that the City will tear down before he gets a chance to finish it. Concerned with leaving the slab in place and never completing project.
