

MINUTES
BOARD OF PUBLIC WORKS AND SAFETY
MARCH 12, 2015

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9:01 a.m., in Council Chambers of Hammond City Hall. A roll call was taken: Mr. Krusa - present; Mr. Dostatni – present; Mr. Smith – present.

Motion by Mr. Dostatni to approve the minutes of the meeting of February 26, 2015; seconded by Mr. Smith. AYES ALL. Motion carried.

Change Order No. 1 for the Sheffield Avenue Bike Trail from 136th Street to 129th Street received from First Group Engineering, Inc. Mr. Dostatni advised the change order represents the cost of 150 watt high pressure sodium luminaires to energy efficient LED luminaires with a cost to the City of \$14,632.64. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 15-159)

Agreement for design service with First Group Engineering, Inc. for 4th District Road Construction – 174th Street from Van Buren Avenue to Monroe Avenue. Mr. Dostatni said the cost of the agreement is \$21,600. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 15-160)

Correspondence received from AT&T requesting permission to perform work on Michigan Street. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 15-161)

Correspondence received requesting approval of the promotion of Office G. Adkins to the rank of Sergeant, the Hammond Hermits Athletic Associate holding a parade May 2, 2015 with “Residential Parking” restriction lifted on Dearborn Avenue from 141st Street to 142nd Street and Disposal Authorizations received from the Hammond Police Department. Mr. O'Connor said the Board is incorrect regarding this action and Mr. Key did try to pay the fee but his check was returned. Motion by Mr. Smith to continue this matter to April 2, 2015; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 15-169)

Rental registration hearing on property located at 903 Bauer Street. Property owner, Ms. Norma Herrera, fails to appear. Motion by Mr. Smith to deny the appeal and assess rental registration at \$80 per unit with the late fee of \$500; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 15-170)

Rental registration hearing on property located at 7755 Bertram Avenue. Property owner, Mr. Ronald Hansen, appears. Mr. Hansen said he did not receive a bill and both he and his wife lost their job in 2014. Motion by Mr. Dostatni to refer this matter to the Engineering Department; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 15-177)
