Hearing on property located at 5965 Hyslop Place. Property owner, Ms. Silvia Becerra, appears. Mr. Matt Saliga, Inspector, Inspections Department, appears. Mr. Saliga stated the ceiling height does not meet code, no egress and the work to convert the basement into an apartment was done without any permits.
