## BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF MAY 31, 2018

Motion by Mr. Margraf to defer approval of the minutes of the meeting of May 24, 2018; seconded by Mr. Long. AYES ALL. Motion carried.

Hearing on property located at 10 Rimbach Street. Attorney Dal Santo appears for the property owner. Mr. Kearney requested that an inspection needs to be completed at the property as at one (1) time it was a six (6) unit multi-family building. Mr. Dal Santo said the building is currently vacant and the property owner has asked for a ninety (90) day continuance. Mr. Castro, Inspector, Inspections Department, requested the Board affirm the Findings he presented regarding the property. Motion by Mr. Margraf to approve the Findings and set this matter for a ninety (90) day status; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 18-400)

Status of property located at 1524 Summer Street. Property owner, Mr. Jose Galvan, appears. Mr. Kearney advised the building has been demolished and should be taken off of the demolition list. Ms. Garay said an Order to Rescind the Demolition Order request will need to be referred to the Law Department Motion by Mr. Margraf to refer this matter to the Law Department for preparation of an Order to Rescind; seconded by Mr. Long.
