MINUTES BOARD OF PUBLIC WORKS AND SAFETY AUGUST 15, 2013

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9:02 a.m., in Council Chambers of Hammond City Hall. A roll call was taken: Mr. Lendi – present; Mr. Dostatni – present; Mr. Smith – present.

Motion by Mr. Dostatni to defer the approval of the minutes of the meeting of July 11, 2013 and July 25, 2013; seconded by Mr. Lendi. AYES ALL. Motion carried.

Correspondence received from Robinson Engineering requesting permission for Geocon Professional Services, LLC to have access to Calumet Avenue right of way to perform two (2) soil borings. Motion by Mr. Dostatni to deny the request as there are large water mains in this area; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 13-786)

Correspondence received from AT&T requesting permission to perform work at Sibley Street and Hohman Avenue. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 13-787)

Correspondence received from Grimmer Construction, Inc. requesting permission to close 169th Street from Calumet Avenue to Harrison Avenue from August 14, 2013 to November 1, 2013 for the installation of a water main. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 13-788)

Correspondence received from BP Pipelines requesting permission limit access to Hump Road. Mr. Dostatni advised that BP will place barricades to block entrance to a driveway on Hump Road that was installed without permits. Mr. Dostatni then said that BP's pipelines are under the entrance and this is being done to avoid damage to the lines. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. Correspondence received from Chief of Police Brian Miller requesting approval of the promotion of Officers E. Gonzalez and D. Young to the rank of Sergeant with pay adjustment effective August 15, 2013. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 13-790)

Hearing on the denial of a business license to Estrella's Sports Bar. Ms. Melissa Estrella appears with her attorney, Mr. Marco Molina, Ms. Estrella stated that she did not complete the application for the permit and did not understand why her name was being brought into the application process. Ms. Estrella then said the Hammond Police Department called her to ask for her date of birth and she thought it was because her ex-husband had filled out the application. Mr. Lendi then asked Ms. Estrella if she filled out or signed the application. Ms. Estrella said that she did not. Mr. Lendi then showed Ms. Estrella and her attorney the permit which shows Ms. Estrella listing herself as a property owner and showing her signature as the applicant. Mr. Molina then stated that property paperwork will be submitted for Mr. Merced Estrella. Motion by Mr. Dostatni to deny the application for a business license; seconded by Mr. Smith . AYES ALL. Motion carried. (Ins. No. 13-791)

Hearing on the denial of a business license to Real T. Tattoos. Ms. Araceli Gutierrez stated that she listed her fiancée, Mr. Darnell Jones, who has criminal felony convictions, on the application and will reapply in her name only. Motion to deny the business license by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 13-792)

Star Foods Business License Revocation Hearing. Attorney Steven Alvarez appears with the owners of Star Foods. Mr. Alvarez stated that he wanted the lab results of the synthetic marijuana that was found at Star Foods as that was originally what the license was revoked for. Mr. Alvarez then said the corporation is being dissolved. Mr. Lendi advised that no license exists and the store should be closed until it is relicensed. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 13-793)

Hearing on property located at 3847 - 49 Sheffield Avenue. Attorney Gary Matthews appears for the property owner. Mr. Matthews said he has requested an inspection and requested additional time to have the inspection completed. Motion by Mr. Smith to continue this matter to September 12, 2013; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 13-794)

Hearing on property located at 40 Warren Street. Mr. Matthews appears for the property owner. Mr. Mathews stated that he has requested a meeting the Building Department and Corporation Counsel Kristina Kantar and requested additional time. Motion by Mr. Smith to continue this matter to October 10, 2013; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 13-795)

Hearing on property located at 4834 Ash Avenue. Mr. Matthews appears for the property owner and stated the second floor is vacated, as is the main floor as a water main broke. Mr. Matthews then said the owner has asked the bank if they would accept a deed in lieu of foreclosure. Mr. Nick Farrell, Inspector, Inspections Department, asked for a status date in this matter. Motion by Mr. Smith to set this matter for status on October 10, 2013; seconded by Mr. Dostatni. AYES

Mr. Farrell requested the Board affirm a deed restriction on the property which stated the second floor cannot be used for sleeping quarters or occupancy. Motion by Mr. Smith to affirm the deed restriction; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 13-800)

Rental registration hearing on property located at 1020 Becker Street. Attorney Amanda Hires appears for the property owner. Mr. Farrell stated that an inspection will be done next Tuesday. Motion by Mr. Smith to continue this matter to October 3, 2013; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 13-801)

Rental registration hearing on property located at 931 Wilcox Street. Property owner, Mr. Esteban Barraza, appears. Mr. Barraza stated that he was unaware that rental registration was due and payable yearly. Mr. Kearney advised that this property has never been registered and an inspection be done. Motion by Mr. Smith to continue this matter to September 12, 2013; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 13-802)

Rental registration hearing on property located at 7230 McCook Avenue. Property owner, Ms. Melissa Gonzalez Benavides, appears and stated that she mailed a check to the Inspections

Department, then called Inspections to ensure the check was received, was told it was not. Ms. Benavides then said when she came to City Hall to pay it was after the deadline passed. Motion by Mr. Smith to waive the late fee and assess rental registration at \$80; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 13-804)

Rental registration hearing on property located at 4717 Ash Avenue. Property owner, Mr. Enrique Nunez, appears and stated that he lived at this address until November of 2012 and rented it in January of 2013. Mr. Nunez said this is the first time he has rented property and was unaware of the fee for rental registration. Motion by Mr. Smith to waive the late fee and assess rental registration at \$80; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 13-805)

Mr. Lendi then thanked Councilwoman at Large Janet Venecz for attending today's hearing.

Under Meeting Opened to the Public, the owner of a beauty shop and an apartment manager whose office is on Calumet Avenue came to protest the placement of "Residential Only" parking signs the 118th Street side of Calumet Avenue. The beauty shop owner stated that she has elderly clients patronizing her business and now cannot park on 118th Street. The apartment manager stated there is parking for two (2) cars behind the building for residents. Mr. Lendi stated the signs will be removed by the Street Department.

Mr. Alvin Cheeks appeared before the Board to thank the Hammond Fire Department in their efforts to save his mother but unfortunately she did not survive.

There being no further business to come before the Board, motion by Mr. Dostatni to adjourn; seconded by Mr. Smith. The regularly scheduled meeting adjourned at 10:07 a.m.
