- 1. The United States of America and the Secretary of Housing and Urban Development be, and hereby are, assured of full compliance and administration of Civil Rights Act, citizen participation, equal opportunity, relocation payments, affirmative action, acquisition processes, accounting processes, the Hatch Act, minimum wage and minimum hours provisions of the Fair Labor Standard Act, and requirements of the National Environmental Policy Act of 1968.
- 2. The Mayor the City of Hammond, Indiana is authorized and directed to prepare an application for the 2018 grant (year ending March 31, 2019) and to execute the proposed programs including all understandings and assurances contained herein as provided in this Resolution.
- 3. Applications on behalf of the City of Hammond for a grant up to \$2,747,385.00 of said Title I funds and for the purpose of seeking Title II funds as specified by the application's Consolidated Plan is hereby approved and that the Mayor of the City of Hammond is hereby authorized to execute and file such application with the Federal Department of Housing and Urban Development, to provide such additional information and to furnish such documentation as may be required of said Department, and act as the authorized correspondent of the City of Hammond relating to the Community Development Program.
