RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAMMOND AUTHORIZING THE
 FILING OF THE CARES-ACT APPLICATION
 AND DESIGNATING SIGNATORIES FOR PAYMENT VOUCHER ON LETTERS OF CREDIT
 FOR THE CARES-ACT PROGRAMS

WHEREAS, On March 27, 2020, President Donald Trump signed into law the Coronavirus Aid, Relief, and Economic Security Act (CARES-ACT). The \$2.2 trillion stimulus measure is the largest federal response in history aimed at providing much-needed relief to the American people and businesses in response to the coronavirus (COVID-19) outbreak; and

WHEREAS, the CARES-ACT made available \$5 billion in supplemental Community Development Block Grant (CDBG) funding for grants to prevent, prepare for, and respond to coronavirus (CDBG-CV grants) and an additional \$4 billion in Emergency Solutions Grant (ESG-CV funds) to supplement the Fiscal Year (FY) 2019 allocations; and

WHEREAS, it is necessary and in the public interest that the City of Hammond, Indiana avail itself of the financial assistance provided through the CARES-ACT to meet the community development and homeless needs that have been exacerbated by COVID-19.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Hammond, Indiana that;

1. The United States of America and the Secretary of the U.S. Department of Housing and Urban Development be, and hereby are, assured of full compliance and administration of

Civil Rights Act, citizen participation, equal opportunity, relocation payments, affirmative action, acquisition processes, accounting processes, the Hatch Act, minimum wage and minimum hours provisions of the Fair Labor Standard Act, and requirements of the National Environmental Policy Act of 1968.

2. The Mayor of the City of Hammond, Indiana is authorized and directed to prepare an application for \$1,892,492 of CDBG and ESG funds made available to the City through the CARES-ACT by amending its currently adopted PY2019 Annual Action Plan submission to HUD.
3. The Mayor of the City of Hammond is hereby authorized to execute and file such application with the U.S. Department of Housing and Urban Development, to provide such additional information and to furnish such documentation as may be required of said Department, and act as the authorized correspondent of the City of Hammond relating to the Community Development Programs.
4. The Mayor of the City of Hammond, Indiana is Thomas M. McDermott, Jr. and is authorized to certify that the signatures of Africa Tarver and Megan Flores are authorized to sign Standard Form 1194 "Authorized Signatory Card for Payment Voucher on Letter of Credit", on behalf of the City of Hammond, Indiana.
5. Any and all funds received under the above application shall be expended only in strict compliance with all applicable federal laws and regulations, and, upon appropriation thereof by the Common Council.


