

RESOLUTION NO. 807

A RESOLUTION AUTHORIZING THE HAMMOND FIRE DEPARTMENT TO APPLY FOR THE ASSISTANCE TO FIREFIGHTERS GRANT (AFG)

WHEREAS, the Hammond Fire Department requires certain equipment to handle safety issues and evolving threats and hazards that exist to firefighters during active threat situations; and

WHEREAS, this equipment includes basic ballistic protection for first responding firefighters, paramedics, and EMTs; and

WHEREAS; the Assistance to Firefighters Grant (AFG) has helped firefighters and other first responders obtain critically needed resources necessary for protecting the public and emergency personnel from fire and related hazards; and

WHEREAS, currently a FY 2020 AFG is available through the Federal Emergency Management Agency (FEMA); and

WHEREAS, this grant, if awarded, would cover 90% of the cost of the new equipment estimated to be two hundred ninety thousand dollars (\$290,000.00), which would leave the City of Hammond responsible for a share of 10% equal to twenty-nine thousand dollars (\$29,000); and

WHEREAS, the City of Hammond must apply for the AFG to be awarded these grant funds and the Hammond Fire Department wishes to make this Grant Application and requires the Approval of the Hammond Common Council; and


