**ORDINANCE NO. 9456**

**AN ORDINANCE CREATING A NEW FUND (FUND #244) AND TO APPROPRIATE FUNDS WITHIN THE HAMMOND POLICE DEPARTMENT GRANT FUND FOR 2020**

WHEREAS, Resolution No. 19R-21 passed on the 26th day of August, 2019 authorized the Hammond Police Department to apply to the Indiana Criminal Justice Institute for a 2020 Lake County Drunk Driving Task Force grant which offers money to law enforcement agencies for the purpose of preventing drunk driving injuries and fatalities and Hammond received an award of these funds; and

WHEREAS, the City of Hammond Police Department requires the use of monies received from the 2020 Lake County Drunk Driving Task Force which requires creation of a Fund (#244) and an appropriation; and

WHEREAS, the 2020 Lake County Drunk Driving Task Force grant has awarded the City of Hammond Police Department \$80,000; and

WHEREAS, these funds are currently available and will be used for and appropriated to newly created Fund #244; and

WHEREAS, this transaction, being an appropriation must have a public hearing for which the Clerk of the Common Council is hereby directed to make arrangements, and being subject to approval by the Department of Local Government Finance (DLGF).


**THEREFORE BE IT ORDAINED**, by the Common Council of the City of Hammond that the following appropriations be and are hereby made as follows:




