ORDINANCE NO. 7702

AN ORDINANCE ESTABLISHING A NON REVERTING FUND FOR THE COLLECTION OF PENALTIES.

WHEREAS, The City has enacted Ordinances regulating sources of air pollution and establishing penalties for non-compliance; and

WHEREAS, the Indiana Department of Environmental Management require by statute, rule or regulation, the use of penalties recovered to be used solely for the purposes of the Hammond Department of Environmental Management; and

WHEREAS, a fund must be established to collect the penalties generated by the enforcement of any environmental ordinance with those funds being utilized for the purposes of the Hammond Department of Environmental Management.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond:

Section 1: A non reverting fund designated the "Environmental Management Special Fund - Penalties" shall be established for the collection of any funds and/or penalties collected through any environmental enforcement action.

Section 2: The funds in the Environmental Management Special Fund - Penalties shall be used solely to support

the programs and/or projects of the Hammond Department of Environmental Management.

Section 3: That the account shall be set up as follows:

BE IT FURTHER ORDAINED by the Common Council that this ordinance shall be in full force and effect from and after passage, signing by the President of the Common Council and approval by the Mayor.
