ORDINANCE NO. 9396

**AN ORDINANCE CREATING A NEW FUND (FUND #256) FOR THE CITY OF
HAMMOND POLICE DEPARTMENT FOR DUI TASKFORCE FUNDS**

WHEREAS, The Hammond Police Department is a sub-recipient of the DUI Taskforce Indiana Grant which was awarded to the Hobart Police Department (Exhibit A); and

WHEREAS, The Hammond Police Department requires a dedicated fund to receipt and disburse this grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, Heather Garay, City Controller, requests that a new account, number 256 be dedicated and created for the City of Hammond Police Department for purposes of accessing funds for the DUI Taskforce Grant with the Revenue Account being 256-331.00 and the Budget Account being 256-41102.201; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate and create a new account for the City of Hammond as follows:

CITY OF HAMMOND #256 DUI TASKFORCE GRANT

BE IT FURTHER ORDAINED by the Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor and approval of the DLGF.
