RESOLUTION NO. R07

**A RESOLUTION AUTHORIZING THE CITY OF HAMMOND TO SUBMIT AN  
IMPLEMENTATION GRANT FOR SAFE STREETS AND ROADS FOR ALL**

WHEREAS, the City of Hammond values the life, health, and safety of all persons living and traveling within the city and that no one's life or limb should be placed in danger while traveling the city streets; and

WHEREAS, the City of Hammond wishes to reduce traffic fatalities and serious injuries of all roadway users on Hammond roads; and;

WHEREAS; the City Council and Mayor earlier this year passed Resolution 24R-05 that adopted a Vision Zero policy, which sets a goal to reduce crashes involving fatalities and serious injuries on city streets by 40% by 2035; and


WHEREAS, the City of Hammond, through its Engineering Department, is seeking to submit an implementation grant for Safe Streets and Roads for All that will assist in reaching the Vision Zero goal as set forth herein and that said grant application is due on or before May 16, 2024 and as part of said grant shall adopt a Comprehensive Safety Action Plan pursuant to the previously adopted provisions of the Vision Zero policy; and


BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond, that the City of Hammond through its Engineering Department be authorized to apply for an implementation grant for the Safe Streets and Roads for All (SS4A) grant program on or before May 16, 2024.
