The project is located on the NICTD Westlake line at Russell Street. The below services are anticipated to be needed for this project:

- Environmental Document Preparation Limited Environmental Documentation:
  - Wetlands & Waters Delineation, Section 401/404 permitting and a recommended Cultural Resources memo
- Topographic Survey Data Collection
  - Perform a topographic survey of the site
  - Geotechnical Engineering Services
    - Perform borings and geotechnical investigation to properly determine existing conditions and design of the platform foundation.
- Platform Design
  - Design the platform in accordance with NICTD, FRA and AREMA standards and requirements.
  - Design the platform match the horizontal and vertical alignment of the approach to the Downtown Hammond Station, complete with canopy structure(s)
  - Design of seating elements
  - Design of deicing elements
  - Coordination with Train Station FFE
