NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY

and 6917 Marshall Avenue in the City of Hammond, and more particularly

and, therefore, the aforementioned 104.83 foot portion of an east-west Alley is hereby

vacated, subject to easements, if any, for existing water, sewer, gas,

telecommunications, and utilities in place and adjoining lots are extended by operation

of law to include the proportionate part of the east-west Alley hereby vacated.

BE IT FURTHER ORDAINED that the Ordinance herein shall have full force and effect from and after Public Hearing hereon, passage and approval by the Common Council of the City of Hammond, Lake County, Indiana, signed by the President thereof, and the approval and signing by the Mayor.
