A RESOLUTION AUTHORIZING THE HAMMOND FIRE DEPARTMENT TO APPLY FOR A 2014 INDIANA DEPARTMENT OF HOMELAND SECURITY (IDHS) GRANT

WHEREAS, the Hammond Fire Department, due to age and wear and tear needs to replace rescue rope and hardware for use in high angle rescue and confined space emergencies; and

WHEREAS; currently a 2014 IDHS (Indiana Department of Homeland Security) grant is available in the amount of Four Thousand (\$4000.00) dollars; and

WHEREAS, this grant does not require matching funds on the part of the municipality and no funds would have to be expended to receive this grant; and

WHEREAS, the City of Hammond must apply for and be awarded these IDHS grant funds and the Hammond Fire Department wishes to make this Grant Application and requires the Approval of the Hammond Common Council; and

BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond, that the Hammond Fire Department be authorized to apply for 2014 IDHS Grant for the purpose of purchasing new rescue grade rope and hardware.

BE IT FURTHER RESOLVED by the Common Council of the City of Hammond that this resolution shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor.
