ORDINANCE NO. 9633

**AN ORDINANCE CREATING A NEW FUND (FUND #2485) FOR INDIANA  
DEPARTMENT OF HOMELAND SECURITY EMS TRAINING GRANT FUNDS  
AWARDED TO THE HAMMOND FIRE DEPARTMENT**

WHEREAS, the Indiana Department of Homeland Security (IDHS) Division of  
Emergency Medical Services created a funding program to support EMS training in alignment  
with local needs identified by IDHS, with a focus on ensuring first responder training and citizen  
safety; and

WHEREAS, the IDHS EMS Training Grant program awarded the City of Hammond  
through the Hammond Fire Department an award of \$20,000; and

WHEREAS, the City of Hammond requires the use of these monies received from the  
EMS Training Grant which requires dedicated funds to receipt and disburse this allocation of  
grant money; and

WHEREAS, the City of Hammond must now have new funds established for receipt and  
distribution of these funds; and

WHEREAS, the City Controller, requests that a new account be dedicated and created for  
the City of Hammond for purposes of accessing funds for FY2024 INDHS EMS Training Grant;  
and

WHEREAS, the creation of this fund is not an additional appropriation and a public  
hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of  
Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and  
create a new account for the City of Hammond as follows:


