ORDINANCE NO. 9634

AN ORDINANCE CREATING A NEW FUND (FUND #2484) FOR HUD HOME INVESTMENT PARTNERSHIP PROGRAM – AMERICAN RESCUE PLAN FUNDS AWARDED TO THE CITY OF HAMMOND

WHEREAS, through the U.S. Department of Housing and Urban Development (HUD), the American Rescue Plan appropriated \$5 billion dollars to help communities provide housing, shelter, and services for people experiencing hardships; and

WHEREAS, the HUD’s HOME Investment Partnerships Program – American Rescue Plan (HOME-ARP) allocated \$1,765,004 to the City of Hammond with expenditures available until September 2030; and

WHEREAS, the City of Hammond requires the use of these monies received from the HOME-ARP which requires dedicated funds to receipt and disburse this allocation of grant money; and

WHEREAS, the City of Hammond must now have new funds established for receipt and distribution of these funds; and

WHEREAS, the City Controller, requests that a new account be dedicated and created for the City of Hammond for purposes of accessing funds for FY2021 HOME-ARP; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:


