WHEREAS, the Office of Community Oriented Policing Services (COPS), a division of the U.S. Department of Justice, administers the FY24 Law Enforcement Mental Health and Wellness Act (LEMHWA) Implementation Projects, which provides grants to entities to support annual mental health wellness checks, mental health counseling services, and critical incident stress management services to its first responders; and

WHEREAS, after successful application to the program, COPS has awarded the City of Hammond Police Department \$200,000.00 for FY2024 for the purpose of prioritizing the mental health of its members and their families; and

WHEREAS, the City of Hammond Police Department requires the use of these monies received from the LEMHWA Implementation Project which requires a dedicated fund to receipt and disburse this allocation of grant money; and
